Tuition and Fees Procedures

- Our tuition and fees are contracted for the entire school year. Refunds are granted in accordance with our Educational Services Agreement. If a student enters TCS during the school year, tuition will be prorated based on the number of remaining months of school.
- **Tuition Payment Options (selected at the time of enrollment)**
 - **10 or 12-Month Installment Plan** - FACTS is used by Christian schools across the country to provide parents a method to divide their payments into equal monthly (or bi-monthly) payments beginning in June or August and ending in May. Late enrollment would alter the number of monthly payments accordingly. All monthly payment plans must be processed through FACTS. Payments are made to FACTS by electronic check or credit card. There is a \$55 enrollment fee for this plan.
 - **Prepay Plan** – TCS offers a 2% prepay tuition discount for accounts paid in full by July 15th. We offer a 1% discount for accounts paid in two installments by July 15th and December 15th. There is a \$25 enrollment fee for these plans.
- **Enrollment fees** must be submitted to complete the enrollment process and secure class placement for the school year. Should a waiting list arise in a particular class, a seat of the student who has an incomplete enrollment packet may be forfeited. The enrollment fee is non-refundable.
- **Student Activity fees** help support student academic and co-curricular activities that tuition does not cover. Fees are payable by October 15th. The student activity fee is non-refundable.
- **Family Volunteer fees** encourage more families to get involved in events and programs that will help TCS continue to grow this ministry. The fee is refundable at the end of the year after completing a minimum of five volunteer hours.
- **Extended Care program** students are permitted to arrive to school as early as 7:00am and can be picked up no later than 5:45pm. Rates are \$2.50 per half hour.

Variable Tuition

FACTS Grant and Aid – Current families wishing to apply for Variable Tuition must submit the application by March 31st. New families may apply during the admissions application process. Awards are granted on a first come first serve basis and may be limited in availability due to funding and budget constraints. PK4 students are not eligible for a tuition reduction.

Non-refundable fees:

- Online Application fee (new student):
 - Sept 16 – June 30: \$95
 - After June 30: \$150
- Registration Fee (new student): \$210
- Student Activity Fee: \$150 per child
- FACTS Grant & Aid Application fee - \$40

- Volunteer fee: \$100 per family**
- **Refundable after completing five volunteer hours.
